**RELEASE and WAIVER OF LIABILITY**

(Our lawyer says that everyone has to sign this legal document in order to be a guest at CASA.)

**Welcome to Central Arkansas Shooters' Association!**

1. Please help us make CASA safe. (CASA means Central Arkansas Shooters' Association, Inc., and its agents, directors, officers, employees, servants, contractors, subcontractors, members, volunteers, instructors, safety officers, range officers, helpers, and affiliates of any kind).
2. Gun accidents can result in serious bodily injury or even death. Sometimes people with guns can create dangerous situations. Always treat every gun like it is loaded. Assume the gun will go off by accident, so always keep it pointed at the berm when loading or unloading (the berm is the big pile of dirt that looks like a river levee). The berm is the only safe place to point the gun and for bullets to impact. CASA cannot and does not guarantee the safety of individual(s) or that individual(s) will act safely. CASA cannot and does not represent that firearms or other equipment, used in guest activities, are safe or free from defects.
3. Always wear eye and ear protection.
4. Any dispute or controversy between you and CASA, relating to this Contract, including the validity or enforceability of any condition, or the entire Contract, shall be settled by arbitration. Arbitrator's decision shall be final and binding, with no appeal. BOTH PARTIES WAIVE A TRIAL BY JURY.
5. In consideration of being permitted to enter CASA property or participate in recreational guest activities at CASA, I hereby release CASA from any and all liability which may arise out of any loss, damage, injury or death which I may sustain, whether caused by the negligence of CASA, or otherwise, and any theft or unexplained disappearance, or damage to my property, or the property of those accompanying me while on the premises of the CASA range. I understand that I am responsible for any damage to CASA property or to the property of others using the range caused by me, my family member(s), or guest(s). I further agree to abide by all safety rules and range regulations set by the Board of Directors of CASA and/or the bylaws of CASA, Inc. I understand that my failure to comply with these rules and regulations may result in my being asked to leave the premises and not return.
